**Reserve Law Enforcement Officer of the Year Award - The two categories are for Valor and Meritorious Service**

**Criteria: Award for Valor**

- ★ Award will be based on outstanding performance while on-duty, which involved a life threatening situation or saving the life of another.
- ★ The officer's chief or sheriff must support the nomination in writing.
- ★ Officer's cannot nominate themselves.

**Application Procedure – Award for Valor**

- ★ Nominee Application must include the following:
  - ⇒ A written narrative of the events and/or activities that the officer is being nominated for.
  - ⇒ A brief resume of the officer's background, training, citations or awards received.
  - ⇒ Letters of commendation, newspaper clippings, or other information, if applicable.
  - ⇒ Two letters of recommendation referencing the specific event from community leaders (one can be chief or sheriff).
  - ⇒ One passport sized photo of the nominee.
- ★ Nominee agrees that RPOA can use submitted information for publication unless otherwise specified.
- ★ Only one award winner per year.
- ★ Cash award to be determined by selection committee.

**Criteria: Award for Meritorious Service**

- ★ Award will be based on outstanding performance of the nominee in the areas of law enforcement service, community activity, education or training.
- ★ The officer's chief or sheriff must support the nomination in writing.
- ★ Officer's may nominate themselves

**Application Procedure – Award for Meritorius Service**

- ★ Nominee Application must include the following:
  - ⇒ A detailed essay of the events and/or activities that the individual is being nominated. Essay must be between 250 and 500 words.
  - ⇒ A detailed resume of the officer's background, volunteer community service (particularly other than law enforcement volunteer/part-time service), education and training, citations or awards received, letters of commendation, and any other applicable information.
  - ⇒ Two letters of recommendation referencing the specific event from community leaders (one can be chief or sheriff).
  - ⇒ Newspaper or other articles, if applicable.
  - ⇒ One passport sized photo of the nominee.
- ★ Nominee agrees that RPOA can use submitted information for publication unless otherwise specified.
- ★ Only one award winner per year in each category will be selected.
- ★ Cash award to be determined by selection committee.
